

AN ORDINACE REGULATING THE OPERATION OF PEDICAB OR "SIKAD" RENDERING OR OFFERING TO RENDER " TRANSPORT SERVICES FOR-A-FEE " IN THE MUNICIPALITY.

BE IT ENACTED BY THE SANGGUNIANG BAYAN OF TUNGAWA, ZAMBOANGA DEL SUR, IN SESSION ASSEMBLED, THAT;

SPONSORED BY: HON. VIDAL R. GARCIA, SR.
CO SPONSORED BY: HON. EDELIA T. HAGONoy

Section 1 - No person, private or juridical, shall engage in the business of rendering or offering to render transport services for-a-fee using pedicab or " sikad" in the municipality without first securing business permit for the operation thereof.

Section 2 - In no case shall minors or those below 18 years of age be allowed to engage in the business provided in the preceding section hereof.

Section 3 - There shall be collected from every operator of pedicab rendering or offering to render transport services for-a-fee an annual permit fee, based on the number of unit being used.

ANNUAL
PERMIT FEE

On " Pedicab-for-hire business " per unit . ₱50.00

Section 4 - Time of Payment. The Permit Fee imposed herein shall be due on the first twenty (20) days of January and payable to the Office of the Municipal Treasurer within the first twenty (20) days of January of every year, the transport unit being used which been acquired after the first twenty (20) days of January, the Permit Fee shall be paid without penalty within the first twenty (20) days of the quarter following the date of its acquisition or purchase.

Section 5 - Surcharge for Payment. Failure to pay the fee imposed in this Ordinance within the time required shall subject the taxpayer to a surcharge of twenty percent (20%) of the original amount of fee due, such surcharge to be paid at the time and in the same manner as the original amount of the due.

Section 6 - Exemption of Other Transport Pedicabs. Transport pedicabs being utilized as a component of duly established enterprise which are not being offered for hire including those being used privately are exempted from the provisions of this Ordinance.

Section 7 - Administrative Provisions.

a) A numbered plate, metal or otherwise, shall soon be provided by the Office of the Municipal Treasurer to be paid at cost by the applicant pertaining to such business undertaking;

b) The Office of the Municipal Treasurer shall keep a register of all transport pedicabs being issued a numbered plate, the ~~particulars~~ ^{brand and make} of plates issued and such other necessary

- c) The Station Commander or his duly authorized representative shall apprehend drivers of pedicab caught violating the provisions of this Ordinance and shall impound the unit in the commission thereof at the compound of the Police Headquarter in preparation for the filing of the appropriate charge. An impounded unit shall not be released without proper clearance from the Municipal Mayor or his authorized representative and only payment of a ~~poundage~~ amount of FIVE (P5.00) PESOS per day or fraction thereof, but not exceeding an aggregate total of FIFTY (P50.00) PESOS.
- d) The Municipal Mayor or his duly authorized department head shall issue the necessary rules and regulations for the proper implementation of this Ordinance provided that such rules and regulations shall not be in conflict with or contrary to the essence, intents or purposes of this Ordinance, otherwise the provision of the latter shall prevail.


Section 8 - Penalty. Any violation of the provisions of this Ordinance shall be penalized of not exceeding FIVE HUNDRED (P500.00) PESOS or an imprisonment of not exceeding thirty (30) days, or both fine and imprisonment, at the discretion of the court.

Section 9 - Separability Clause. If, for any reason, any provision of this Ordinance is declared not valid by a court of competent jurisdiction, such judgement shall not affect or impair the ~~remaining provisions of this Ordinance~~ to be in full force and effect.

Section 10- This Ordinance shall take effect upon its approval following the posting of a copy thereof in all conspicuous places of the municipality.
