BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF TUNGAWAN, SAMBOANGA DEL SUB, IN SESSION ASSEMBLED, THAT:

Section I- TITLE- This Ordinance shall be known as: AN ORDINANCE FIXING REGISTRATION FEES ON LARGE CATTLE AND TRADERS' CLEARANCE FEE OF AGRICULTURAL OR FOREST PROLUCTS, ITS BY- PRODUCTS AND LIVESTOCK, AMENDMENT TO PROVISION OF UPDATED ME CODE (SUBSECTIONS H.1. 5 AND H.301, SECTION 5 A. 02. ARTICLE A. CHAPTER 5) AND ITS PENALTIES FOR VIOLATION TH EREFOR.

Section 2- It small be the direct responsibility of the Office of the Municipal Treasury to prevent the movement of agricultural or forest products and livestock without ascertaining the correct imposition of municipal tax authorized under existing laws for the purpose of generating revenue to this local government unit.

Section 3- The person immediately accountable to the collection thereof shall be liable to observe the following schedule:

- Section 4- Any person who maliciously, feloniously and intentionally abetting and confederating with each other to violate any provision of this Ordinance shall be penalized of not less than /IT but not more than /2T and imprisonment of not more than One(1) month or both upon the discretion of the court.
- Section 5- Separability Clause- If for any reason or reasons, any part or provisions of this Ordinance shall be held to be unconstitutional or invalid, the parts or provision which are not affected thereby shall continue to be in full force and effect.
- Section 6- Effectivity Clause- This Ordinance shall take effect upon its approval by the duly constituted authorities and posting thereof in at least 3 conspicuous places of this municipality.
