Series of 2010

**AN ORDINANCE REGULATING THE SELLING AND BUYING OF RUGBY
INCLUDING ITS UNAUTHORIZED POSSESSION IN THE MUNICIPALITY OF
TUNGAWAN, ZAMBOANGA SIBUGAY AND FOR OTHER PURPOSES**

BE IT ORDAINED BY THE 15TH LEGISLATIVE COUNCIL OF TUNGAWAN, ZAMBOANGA SIBUGAY IN ITS 119TH REGULAR SESSION, THAT:

Section 1. *Title* - This Ordinance shall be known as "An Ordinance Regulating the Selling and Buying of Rugby including its Unauthorized Possession in the Municipality of Tungawan, Zamboanga Sibugay"

Section 2. *Purpose* - The purpose of this ordinance is to thwart and eradicate the proliferation of rugby addiction specially among the youth in the municipality;

Section 3. *Definition of Terms* - When use in this ordinance, the following words or phrases shall mean as:

- 3.1. Rugby - Refers to a common name of syrup form substance sold in stores use for joining objects, any broken wares or stuff;
- 3.2. Store - Shall mean a house or shop with duly licensed Business Permit to sell goods and commodities. It includes a hardware, commercial enterprises, trading center and market stall.
- 3.3. Manufacturing & Repair Shops - Refers to vulcanizing shop, shoe repair shop, bag making & repair shop and other shops that use rugby in its operation.
- 3.4. Peddling - The act of selling rugby outside a store, in a house or public places and also while in transit.
- 3.5. Unauthorized Possession of Rugby - This means the holding or carrying of rugby while in the act of peddling or in hand giving of the suspected peddler or carrier to the receiving suspected buyer or user.
- 3.6. Suspected User - A person who have been reported and listed to the Barangay Officials, school authorities and police of snipping rugby;

Section 4. **Selling** - No store owners or sales clerk, and Manufacturing and Repair Shops operator or laborer shall sell or offer to sell rugby to any person of "menor de edad" or person below 18 years old including those persons who are in watch list of the Municipal Police Office as courier or rugby peddler and suspected rugby addict or user.

Section 5. **Peddling** - No person shall engage in peddling this merchandize to any suspected user for the intention of snipping, rugby session and other related activities.

Section 6. **The Municipal Police Office (MPO)** - The Municipal Police Office, through the Chief of Police is enjoined to help in the implementation of this ordinance. Specifically, It shall perform the following tasks:

- 6.1. Monitor, conduct surveillance and apprehend suspected rugby addicts doing actual rugby session or snipping rugby in the municipality.
- 6.2. Monitor, conduct surveillance and apprehend suspected peddlers and suspected users of rugby in the act of peddling and buying or receiving the merchandise while within or going to the place to hold rugby session or rugby snipping.
- 6.3. Conduct symposium and counseling on the effect of Rugby Addiction in school campuses and out - of - school youth.
- 6.4. File appropriate charges against violators of this Ordinance.

Section 7. **The Municipal Social Welfare and Development Officer (DSWDO)** - In coordination with the MPO, the MSWDO shall co-head the conduct of symposium and counseling on the effect of Rugby Addiction in school campuses and OSY, and be responsible in the custody of Juvenile Delinquency Offender of this ordinance.

Section 8. **Funding** - An appropriation for the operation of this ordinance shall be provided in the Annual Budget under the Office of the Municipal Mayor to ensure its effective implementation.

Section 9. **Penalty** - Violations to this Ordinance shall be penalized as follows:

9.1 For In-Of-School and Out-Of-School Youth Offender

1st Offense - Brought the offender to the MPO and call the parents, principal/teacher and MSDWO for counseling and promissory note not to do it again.

2nd Offense - Overnight custody in the MPO with required waiver from parent/guardian and or suspension for 3 days in his classes.

3rd Offense - Referred to the MSWDO for appropriate action.

9.2 Other persons found violating this ordinance shall be fined two thousand pesos (P 2,000.00) or an imprisonment of one (1) month or both upon the discretion of the court.

Section 10. **Repealing Clause** - All ordinances, resolution or executive orders of local application with effect inconsistent hereto are hereby modified, superseded and repealed accordingly.

Section 11. **Separability Clause** - If any part or provision of this ordinance shall be held unconstitutional or invalid, the other provisions hereof shall remain subsisting and in full force and effect.

Section 12. **Effectivity** - This ordinance shall take effect upon its approval by the Municipal Mayor.


