#### GENERAL ORDINANCE NO. 45 Series of 2012

## AN ORDINANCE REGULATING THE USE OF AGRICULTURAL MACHINERIES AND IMPOSING RENTAL FEES THEREOF

Be it Ordained by the 16<sup>th</sup> Legislative Council of Tungawan, Zamboanga Sibugay in its 89<sup>th</sup> Regular Session Assemble, that:

Section 1. This Ordinance shall be known as "An Ordinance Regulating the Use of Agricultural Machineries and Imposing Rental Fees Thereof"

Section 2. The LGU of Tungawan, in accordance with Art. 100 (a), (3) of the Rules and Regulations Implementing RA No. 7160, shall impose and collect reasonable fees or charges for the utilization of its Agricultural Machineries for its operation and maintenance expenses;

Section 3. Any person, association, corporation or cooperative who apply or intend to use the Municipal Government owned agricultural machineries shall, in first come-first-served basis, register his/their intention by filling out an Agricultural Machinery Rental Order and pay the required fees to the Municipal Treasurer or his duly Authorized Representative at the Office of the Municipal Agriculturist.

Section 4. The Schedule of rental fees and charges are as follows:

Unit	Rental Fee or Charges
a. Farm Tractor	 Php 1,000/ha. Plus diesoline
b. Rice Thresher	 2 sacks/25 sacks or
	Php 1,200/25 sacks
c. Hand Tractor	 Php 1,000/ha for 3 times,
	Plus diesoline

The fuel or diesel for the demobilization of the machineries going to the job site and back to its origin, designated garage or to the MAO area shall be borne out by the renter.

Section 5. The collection of rental fees shall be made upon issuance of official receipt by the duly Authorized Representative of the Municipal Treasurer and turn over it to the Municipal Treasurer every 15<sup>th</sup> and 30<sup>th</sup> day of the month for proper disposition and management of funds.

Section 6. The Municipal Mayor may designate the Municipal Agricultural Officer or Municipal Agriculturist who shall perform the following duties and responsibilities:

a. Act as custodian and exercise full diligence as responsible father in utilizing, conserving, protecting and maintaining the aforesaid machineries.

- b. Devise the form for Agricultural Machinery Rental Order (AMRO) and its rules and procedure.
- c. Submit a Quarterly Operation Report to the Local Chief Executive and furnish copy to the Sangguniang Bayan Committee on Agriculture.
- d. Perform other duties and functions as may be required by the Local Chief Executive and the Sangguniang Bayan.

Section 7. Any person found violating the provision/s of the Ordinance shall be fined of One Thousand Pesos for First Offense and Two Thousand Pesos for the Second and succeeding offenses.

Section 8. If any provision/s of this Ordinance shall be held unconstitutional or invalid, the other provisions not otherwise affected shall remain in full force and effect.

Section 9. All Ordinances or parts thereof contrary or inconsistent with the provisions of this Ordinance is hereby repealed, modified or amended accordingly.

Section 10. This Ordinance shall take effect fifteen (15) days after its posting at conspicuous places within the Municipal Hall Bulletin Board and Municipal Public Market in Barangay Libertad.
