# GENERAL ORDINANCE NO. 59 Series of 2016

# "THE SANITATION CODE OF TUNGAWAN, ZAMBOANGA SIBUGAY".

Authored by: Hon. Alfredo L. Jamora Co-Authored by: Hon. Maximo L. Medado

Be it Ordained by the 17<sup>th</sup> Legislative Council of Tungawan, Zamboanga Sibugay in Session, Assembled that:

# CHAPTER I

# **GENERAL PROVISION**

**SECTION 1-TITLE**. This code shall be known and referred to as "THE SANITATION CODE OF TUNGAWAN, ZAMBOANGA SIBUGAY".

**SECTION 2. DECLARATION OF POLICY.** It is hereby declared to be the policy of the Municipality of Tungawan, Zamboanga Sibugay to provide special protection to residents and visitors from any pollution derived from the unscrupulous dumping of garbage.

The best interest of the citizens shall be the paramount consideration in all actions of the municipal government to assure the promotion and preservation of the health, safety convenience and raise the health standards of individuals and communities throughout the municipality.

SECTION 3. – RELATION TO EXISTING NATIONAL LAWS AND PRIOR ORDINANCES - some provision of this code are excerpt from the existing National Legislations and previous ordinances by the Sangguniang Bayan of Tungawan, Zamboanga Sibugay. The same subject matter shall be construed as restatements and not as new enactments, unless otherwise explicitly modified therein.

SECTION 4. - OBJECTIVES - The objectives of this code are as follows:

- A. To ensure round the clock cleanliness through orderly waste management.
- B. To cease and desist from this utilization and open garbage dumps which serve as breeding places of insect causing disease, foul odor which pollute soil and water resources and create unhealthy scavenging activities.
- C. To eradicate garbage and unsightly, uncovered and overflowing waste containers in streets, public places & open spaces.
- D. To minimize pollution arising from harmful gases, smoke, particulars produced by needles burning or dumping, polluted run off into water sources or supply, and hazardous substances and,
- E. To ensure protection and promotion of health of the residents and visitors of the Municipality of Tungawan, Zamboanga Sibugay.

#### **CHAPTER II**

#### **RULES OF CONSTRUCTION**

**SECTION 5. – RULES OF CONSTRUCTION –** In constructing the provisions of the code, the following rules of construction shall be observed unless inconsistent with the manifest intent provisions of this code.

- A. GENERAL RULE All words and phrases shall be construed and understood according to the common and approved usage of the language, but technical words and phrases and such other words in this code which acquired a peculiar or appropriate meaning shall be deduced and understood according to such technical, peculiar or appropriate meaning.
- B. GENDER AND NUMBER Every word in this code importing the masculine gender shall extend to both male and female. Every word importing the singular numbers shall apply to several persons of thing and every word importing the plural number shall extend and apply to one person or thing.
- C. PERSON The word "PERSON" shall extend and be applied to business, corporations and voluntary association, as well as to individuals, unless plainly unapplicable.
- D. TENSES The used of any verb in the present tense shall include the future when applicable. The words "shall" is mandatory and "may" is permissive in nature.

### **CHAPTER III**

#### **DEFINITION OF TERMS**

# SECTION 6. - WORDS DEFINED IN THIS CODE

- A. **ASH** a sort of residue or an end product from the process of burning any materials and thus becoming a contributing factor to air pollution.
- B. BIODEGRADABLE/ORGANIC refer to any material that can be reduced into finer particles (degraded or decomposed) by microbiological organism or enzymes (synonyms with compostable).
- C. COVERED PUBLIC PLACES includes schools, clinics, health centers, laboratories, government or private offices, auditoriums, session halls churches, convention centers, movies houses, studios, bar restaurants, and other enclosed public eating places markets,/groceries and other covered places where people stay or gather for political, social, education, religious, sports or entertainment purposes.
- D. DEAD ANIMALS pets, poultry, swine rodents and other harmful or useful animals that are lifeless when not properly disposed becomes an added factors to air pollution and diseases.
- E. DISCARDED BUILDING MATERIALS those can not be put to use such as nipa and coconut shingles, sawali and other similar materials when changing roofs, walls, etc.

- F. DOMESTIC WASTE are food residues, food preparation waste and spoilages, paper and other paper products, metals, plastic ad rubber, rugs and clothes, process residues, yard trimmings and woods.
- G. FECES human waste matter discarded from the intestine through from the anus.
- H. FOOD ESTABLISHMENT an establishment where food or drinks are manufactured, processed, stored, sold or served.
- GARBAGE anything that is rubbish, trash, and/or coming from food waste that has the tendency to rapidly decompose and produce offensive odors.
- J. IMMDEDIATE SURROUNDINGS refer to frontage, including up to the midspan of the road, street, alley, or avenue (excluding national highways and major thoroughfares) from the edge of the street gutter, sidewalks of residential houses, dwelling units, business/commercial establishments or offices whether private or public.
- K. INDUSTRIAL WASTE are organic and inorganic residues hazardous and toxic chemicals, metals and woods.
- L. JUNK VEHICLES AND APPLIANCES are those abandoned light and heavy vehicles, metal products such as refrigerators, freezers, air conditioners, television, etc.
- M. MANURE an end product and/or waste matter coming from the process of digestive system of animals which can be generally used for fertilizer purposes.
- N. NON-BIODEGRADABLE/INORGANIC anything that is not capable of decaying and not absorbed by the environment such as cellophanes and plastics rubbers and the likes.
- O. OPEN PUBLIC PLACES are roads, streets, sidewalks, easement, parks and other open places, bridges, alleys, rivers, creeks, canals, drainage, waterways, and other bodies of water and outlets.
- P. REFUSE anything discarded that is worthless and waste be it soft or hard materials such as bottles, broken glass, tin cans, waste papers discarded porcelain wares, pieces of metals and other wrapping and packaging materials.
- Q. SPECIAL WASTE- are usually bulky wastes, sewages residues, streets, sweeping, pollution control residues, construction and demolition debris.
- R. STREET AND SIDEWALKS OBSTRUCTION any form of waste which is immovable and bulky in nature because of its size and weight which may obstruction or impede the free flow of traffic and pedestrian.
- S. STREET SWEEPING is one process of cleaning a pave of street locally made cleaning equipment e.g. dust manure leaves, cigarettes, buts, waste papers.
- T. VERMIN a group of insects or small animals such as flies, mosquitoes, cockroaches, fleas, lice, bedbugs, mice and rats which defectors of diseases.
- U. YARD CUTTING twigs, branches, trunks of trees, grass and other similar materials as a result of cleaning the yard.
- V. OTHER WASTE MATERIALS.

# **GARBAGE COLLECTION AND DISPOSAL**

**SECTION 7. – GARBAGE COLLECTION AND DISPOSAL** – Garbage intended for collection and disposal by municipal garbage trucks shall follow the following conditions:

- A. Waste must be separated into biodegradable/organic biodegradable/non-organic waste such as left over foods and other decomposing and degradable matters shall be placed inside plastic bags or containers without leak. These bags or containers shall be brought and put in front of the gates of residential houses, business establishment and households in the interior should deposit their waste along the main streets accessible by the municipal garbage truck upon the arrival of the garbage truck in the area signaled by a specific sound.
- B. Trees, shrubs and grass cutting should not be mixed with the above cited waste. They should be placed inside a separate plastic bag or sack and should follow the disposal process stated above.
- SECTION 8 A. the municipality shall provide in every public place (Strategic place) like terminal, wharfs, parks etc. a waste cans for dry wastes.
  - B. Dumping of domestic waste in the waste cans provided by the LGU is strictly prohibited.
- SECTION 9 All residential houses and business establishment must provide a pit least 1.0M x 1.0 M x 1.0M in size within their lots for biodegradable/organic waste. Household or establishment with no space available for the above cited pit should seek an exemption certificate from the Municipal Engineer' Office.
- SECTION 10 Every household and business shall provide their respective trash container or any form receptax for dry waste disposal and shall be placed in front of the house or at the inner sidewalks and should follow the disposal process as stated in paragraph (A) of this chapter.
- SECTION 11 Throwing or placing of waste in areas not designated for such purpose is strictly prohibited.
- SECTION 12 A. dumping and throwing of garbage and other obnoxious substances along rivers, streams, canals and other bodies of water within Tungawan is strictly prohibited.
- B. Any person dumping domestic waste in any place within the territorial jurisdiction of the Municipality of Tungawan, Zamboanga Sibugay in which the source is outside Tungawan shall be penalized by imprisonment of not more than six (6) months and a fine of Two Hundred (200.00) Pesos or upon discretion of the court.
- SECTION 13 Burning of non-biodegradable objects like plastic wrapper. cellophane, Styrofoam, rugs, tires, rubber and anything that is not capable of decaying and not absorbed by the environment is strictly prohibited.
- SECTION 14 A. The owner/residents leasees or occupants of residential house/dwelling units, vacant lots owners, proprietors, operators, administrators of dormitories, condominiums, commercial building and offices whether private or public institutions like schools and churches are obliged everyday to sweep, clean and maintain the cleanliness of their respective frontage and immediate surroundings, including the sidewalks and street gutters fronting their premises.

- B. Failure or inability to comply with the obligation stipulated in Par A. Sec. 14. the government shall undertake the cleaning at the expense of the owners, lessees or occupants, plus the penalty provided in the penal provisions of this chapter.
- C. In the case of Idle lots, the government may, through the concerned Barangay Council, further utilize the land for its food production program and ceased to be utilized when the owner decided to utilize for his own.
- **SECTION 15** It is the responsibility of the owners to dispose properly dead animals lying in the highways or streets or in any place within the municipality of Tungawan, Zamboanga Sibugay. But in any case there is no claimant or identified owner, it is the responsibility of the owner or occupants of the house or establishment, who is the nearest location of the said dead animal.
- **SECTION 16** The owners, operators, drivers and conductors of public utility vehicles plying with the municipality are obliged to clean and maintain the cleanliness of their respective vehicles at all time and to provide a modest trash receptacles inside their vehicles.
- **SECTION 17** Penalty. Any person who violates any provision on this chapters shall be subject to the following penalties.
  - A. 1st OFFENSE : P 200.00 fine or community service of one (1) day
  - B. 2<sup>nd</sup> OFFENSE : P 500.00 fine and imprisonment of not more than one month
  - C. Subsequent violation shall be penalized with the maximum imprisonment of two (2) months and a fine of One Thousand (P 1,000.00) Pesos and revocation of business permit for business establishment and or upon the discretion of the court.
- **SECTION 18** A. It is a duty of every citizen of Tungawan, Zamboanga Sibugay who has personal, knowledge of any person violating any provision of this chapter to report to authorities the said violation, Failure to do so means a fine of One Hundred ( P 100.00) Pesos.
- B. The Municipal Health Officer shall take the lead in implementing the provisions of this chapter with the assistance of the Police and other persons deputized by the Municipal Mayor.

#### **CHAPTER V**

#### ANTI-LITTERING

- SECTION 19 Throwing of litters like cigarette buds, wrappers, cellophanes, papers, banana cue sticks, and/or waste materials in public places is strictly prohibited.
- **SECTION 20** A. It is the duty of the owner/manager of the business establishment to compel his customer that any waste materials of the goods bought from his establishment should be thrown properly.

- B. If the customer was caught by any person violating Section 19 of this chapter, the owner/manager of the business establishment should be penalized of a fine of Fifty (50.00) Pesos.
- **SECTION 21 PENALTY –** Violation of the provision of this chapter shall be subject to the following penalties.
  - A. 1<sup>st</sup> OFFENSE: P 100.00 fine or community service of five (5) hours or if the apprehended individual cannot afford to pay the prescribed penalty he/she must apprehend another violator for him/her to be freed from the penalty.
  - B. 2<sup>nd</sup> OFFENSE: P 300 fine and imprisonment of not more than fifteen (15) days.
  - C. Subsequent violation shall be penalized with the maximum (500.00) Pesos and or upon the discretion of the court.

**SECTION 22** - It is the duty of every citizen of Tungawan who has personal knowledge of any person violating any provision of the chapter to report to the authorities on the said violation. Failure to do so means a fine of Fifty (50.00) pesos.

# CHAPTER VI CONSTRUCTION OF TOILET

- **SECTION 23** A. Owners, lessees or occupants of residential houses and or business establishment shall have its own toilet "Water Sealed" to the least is acceptable.
- B. The sanitary Inspector shall take the lead in the implementation of this chapter and shall have the regular inspection throughout the municipality.
- C. Failure of the person concern to construct a toilet upon the approval of this code, would mean a first violation. And failure to act within the time stated of the first notice for construction of toilet from the Sanitary Inspector would mean a second violation. And subsequent violation would be determined by the failure of the concern to act within the time stated in the subsequent notices.
- **SECTION 24 PENALTY** Any person who violates any provision of this chapter shall be subject to the following penalties.
  - A. 1st OFFENSE: P 200.00 fine
  - B. 2<sup>nd</sup> OFFENSE: P 500.00 fine
  - C. Subsequent violation shall be penalized with the maximum imprisonment of thirty (30) days and a fine of One Thousand (P 1,000,00) Pesos and or upon the discretion of the court.

# CHAPTER VII SMOKING BAN

**SECTION 25** - A Smoking inside and outside of public building, public offices and public utility jeepneys/vehicles within the municipality of Tungawan, Zamboanga Sibugay is strictly/prohibited.

B. Smoking is allowed only to designated "Smoking areas" within the public building and public places such as but not limited to the following:

Municipal Hall

- Flag Pole Area

Gymnasium

- Outside or in front of Gym

Public Schools

- Outside School Campus

SECTION 26 - any person who violates any provision of this chapter shall be subject to the following penalties;

A. 1st OFFENSE : P 50.00 fine

B. 2<sup>nd</sup> OFFENSE: P 250.00 or community service of one (1) day.

C. Subsequent violation shall be penalized with the maximum imprisonment of thirty (30) days and a fine of Five Hundred (500.00) pesos and or upon the discretion of the court.

# **CHAPTER VIII** URINATING IN PROHIBITED PLACES

SECTION 27 - Urinating in places like fences, walls of public and private buildings, parks, posts and other similar open places is strictly prohibited within the territorial jurisdiction of the municipality of Tungawan, Zamboanga Sibugay.

SECTION 28 - Any person who violates the provision of this Chapter shall be subject to the following penalties.

A. 1<sup>st</sup> OFFENSE :

P 100.00 fine or community service of five (5) hours.

B. 2<sup>nd</sup> OFFENSE: (15) days.

P 300.00 fine and imprisonment of not more than fifteen

C. Subsequent violation shall be penalized with the maximum imprisonment of thirty (30) days and a fine of Five Hundred (500.00) pesos

A. The municipal government should provide a portable comfort rooms to strategic places within the municipality of Tungawan for urinating purposes.

B. The Municipal government shall encourage the participation of Barangay Government, private entities and individuals, Purok organizations and NGO's who will provide portable comfort rooms for rent but subject to regulation and shall comply the necessary requirements set by the municipal government.

# **CHAPTER IX** FOOD ESTABLISHMENT

#### SECTION 30 - SANITARY PERMIT

- A. No person shall operate a food establishment for public patronage without securing a permit from the Municipal Health Office.
- B. Every sanitary permit shall be posted in conspicuous place of the establishment.

#### SECTION 31 - HEALTH CERTIFICATES.

No person shall be employed in any food establishment without a health certificate issued by the Municipal Health Officer. This Certificate shall be issued only after the required physical and medical examinations are performed and immunizations are administered at prescribed intervals.

#### SECTION 32 - QUALITY AND PROTECTION OF FOOD.

All food must be obtained from approved sources, by the Municipal Health Officer, In this regard, the following requirements are applicable.

- A. Meats meat products and fish shall be procured from sources under sanitary or veterinary supervision.
- B. All meats and fish shall be properly cooked before serving.
- C. Raw fruits and vegetables shall be thoroughly washed before they are used.

#### SECTION 33 - WASH - HAND BASINS

- A. Wash-hand basins shall be installed in convenient places and as near as practicable to where the person for whose use they are provide are working while handling food for sale or in such location as may be otherwise prescribed in any particular case.
- B. An adequate supply of soap, clean towels presenting a clean surface to each user or other hand drying services approved by health authorities.
- C. The wash-hand basin and all hand washing facilities shall, at all times, be maintained in good repair and clean condition.

### SECTION 34 - USE OF FOOD SERVICE SPACES

- A. Food service shall not be used as sleeping quarters.
- B. Clothing or personal effects shall be dept in lockers or in designated places away from the food service spaces.
- C. No animal or live fowls shall be allowed in such spaces.
- D. No persons not directly connected with food preparation and serving shall not be allowed to stay in food serving spaces.
- E. Food storage or in preparation must be handled by anyone other than the preparation and serving staff.

# **SECTION 35 - FOOD HANDLERS**

- A. No person shall be employed in any food establishment without a Health Certificate issued by the Municipal Health Officer.
- B. Food Handler shall be at all times.
  - Wear clean working garments, the cook shall wear prescribed caps and female employees should wear caps or hairnets.
  - ii. Observe good personal hygiene
  - iii. Wash their hand thoroughly with high soap and water and dry them with a clean or disposable towel or a suitable hand-drying device immediately before working or after visiting the toilet.

# SECTION 36 - VERMIN CONTROL

- A. Spaces where food and drinks are stored, prepared and served shall be so constructed and maintained as to exclude vermin.
- B. All opening which connects spaces to the outer air shall be effectively protected with screen or non-corrosive wire 16-mesh or finer. Door screens shall be tight-
- C. A vermin abatement program shall be maintained in the establishment by their owners, operators, or administrators if they fail, neglect or refuse to maintain a vermin abatement programs, the Municipal Health Office will undertake the work at their expense, added to the penalty provided in the penal provision of this chapter.
- D. During derating or disinfecting operations, all food-stuff utensils, food preparation and cleaning equipments shall be covered to protect them from toxic chemical substances.
- E. Vermin control in public places shall be the responsibility of the Municipal Government of Tungawan.
- F. The procedure and frequency of vermin abatement program shall be determined and approved by the Municipal Health Office.

#### SECTION 37 - TOILET AND WASHING FACILITIES

- A. Adequate and clean toilet facilities for male and female customers and personnel shall be provided in properly located areas.
- B. Toilet rooms shall not open directly into spaces where food is prepared stored or served. Where such toilets exists, the door shall be tight-fitting and selfclosina
- C. Adequate hand-washing facilities shall be provided within or adjacent to toilet
- D. Facilities shall include hot or cold running water, single-serve paper or cloth towel dispense or drying device and soap or detergent.

#### SECTION 38 - DISPOSAL REFUSE.

- A. Refuse cans may be used in food preparation areas for immediate use only.
- B. Storage refuse cans, filled and empty shall be in designated space separated from food handling operations.
- C. These cans shall be so constructed and maintained as to be vermin-proof and easily cleansed.

#### SECTION 39 - FOOD SERVICING OPERATION

- A. Hand contacts with food or drink shall be avoided. Finger shall not be used to serve butter, ice or similar items of food. Sugar shall be served in covered dispenser or container or in packages wrapped for single service.
- B. The surfaces of containers and utensils, including glasses and tableware, which come in contact with food and drinks shall not be handled.

# SECTION 40 - EVALUATION OF FOOD ESTABLISHMENT

It shall be the duty of the Municipal Health Officer to cause an inspection and evaluation of every food establishment requiring a permit for its operation, at least

every six (6) months and shall cause as many additional inspection and re-inspection and evaluation to be made as are deemed necessary for the enforcement of the provision of this chapter.

#### SECTION 41 - SPECIAL PROVISION.

- A. Eateries/Food served in Toro-toro.
  - All foods served in eateries or toro-toro shall be protected from contamination or shall be properly covered while in counters or showcases.
- B. Ambulant Food Vendors
  - These vendors shall sell only bottled food drinks, biscuits and confectioneries.
- C. Municipal Public Market
  - Only fresh and wholesale fish products shall be sold.
  - 2. The selling distribution and buying of fish caught through the use of explosives and chemicals are strictly prohibited.

#### SECTION 42 RESPONSIBILITIES OF THE MUNICIPAL HEALTH AUTHORITY.

The Municipal Health Authority shall:

- A. Make a period inspection to enforce the maintenance of adequate sanitation in food establishment and their premises.
- B. Take samples of food and drink from any establishments or vendors as often as necessary to determine if they are wholesome, adulterated or contaminated by radio activity.
- C. Prevent the sale or condemn and destroy food and drinks if these are found unfit for human consumption.
- D. Seal and prohibit the use of devices, utensils, containers, vehicles, machine, piping and appurtenances if in his opinion they are unsanitary, and
- E. Enforce the provisions of this Chapter and the Rules and Regulations promulgated by the Secretary of Health.

SECTION 43 - PENALTY - Any person who violates any provision in this chapter shall be subject to the following penalties:

- A. 1st OFFENSE P 300.00 fine
- B. 2<sup>nd</sup> OFFENSE P 500.00 fine
- C. Subsequent violation shall be penalized with the maximum imprisonment of thirty (30) days and a fine of Two Thousand (P, 2,000.00) pesos plus revocation of Business Permit.

# STREET HAZARDS

SECTION 44 - No person is allowed to wash, hang-on bleach clothes, tie domestic animals, dry copra, corn, rice, coffee, firewood, stick, empty bottles of commercial drinks or beverages, bundled firewood, chicken/pig pens, etc. and or

overnight parking of cars, tricycle, motorcycles and trucks parallel along national highway, municipal roads and streets, public market and on the concrete steps leading to the municipal building, within the municipality of Tungawan.

- **SECTION 45** It is unlawful for any person to place, store or dump construction waste or debris, junked or under repair vehicles, dilapidated appliances and other and immovable objects in any parts of the road, streets or avenue or any sidewalks which may obstruct or impede the vehicular and pedestrian traffic.
- **SECTION 46 PENALTY** Any person who violate willfully any of the provision of this Chapter shall be subject to the following penalties:
  - A. 1st OFFENSE P 1,000.00 fine
  - B. 2<sup>nd</sup> OFFENSE P 1,500,00 fine and imprisonment of not more than thirty (30) days.
  - C. Subsequent violation shall be penalized with the maximum imprisonment of Sixty (60) days and a fine of Two Thousand (P 2,000.00) Pesos.

**SECTION 47.** For illegally dumping of bulky waste, factory/construction debris and other similar nature that requires hauling the violator shall be liable to pay additional hauling fee of Two Hundred (P200.00) Pesos per cubic meter in addition to the penalty provided in Section 43 of this Chapter.

# CHAPTER XI VANDALISM

- **SECTION** 48. Definition Vandalism is defined as act of destroying or disfiguring natural or human works of beauty or wan ton destruction or spoiling of what should be preserved.
- **SECTION 49** Destruction or disfiguring any public or private properties or parts thereof by any means of writing or printing of letters, words, signs, and or symbols in any parts of the building, walls, fences, billboards, sign boards, (Bridge Wheel Guard) and the like is strictly prohibited.
- **SECTION 50 PENALTY.** Any person who violates the provision of this Chapter shall be subject to the following penalties:
  - A. 1st OFFENSE: P 500.00 fine or community service of one (1) day.
  - B. 2<sup>nd</sup> OFFENSE: P 1,000.00 fine and imprisonment of not more than fifteen (15) days.
  - C. Subsequent violation shall be penalized with the maximum imprisonment of Thirty (30) days and a fine of Two Thousand Pesos (P 2,000.00).
- **SECTION 51** Special Provision . The violator shall be liable to pay the cost of the original painting and or pay the damaged cost plus the penalty as provided for in Section 49 of this chapter.

### **CHAPTER XII**

# **BACKYARD RAISING OF LIVING STOCK AND FOWL**

# Section 52. Backyard raising of livestock and fowl provided that:

- A. For livestock twenty (20) heads in the urban and ten (10) heads in rural areas, and per fowl, a maximum of fifty (50) birds in urban and Five Hundred (P500.00 birds in rural areas.
- B. No undue noise shall be created by those pets and fowls.
- C. No foul smell shall be emitted.
- D. Other sanitary requirement such as septic tank and other requirements enforced in the municipality are compiled with.
- E. In case in residential subdivision, the provision stipulated in the contract shall prevail over this code.

#### **CHAPTER XIII**

#### SPECIAL PROVISIONS

#### Section 53. PROCEEDS:

- A. If the violator commits the offense in any of the barangays of the municipality of Tungawan and was apprehended by the barangay authorities concerned, 80% of the fine shall go to the barangay and the 20% shall go to the municipal government.
- B. And if the violator was apprehended by any person authorized and/or by any member of the task force created by the municipal government the 20% of the fine shall go to the apprehending officer and the 80% shall go to the municipal government.
- C. The fine shall be paid exclusive to the Barangay Treasurer in the case of the barangay and to the Municipal Treasurer for the Municipal Government and/or by their authorized representative.

#### **SECTION 54 - ISSUANCE OF RECEIPTS**

The Apprehending Officer shall issue a violation acknowledgment receipt or citation ticket to any person who violates any provision in this code, including the name of the violator and the specific address, the name of the apprehending officer and their signatures, the nature of the offense, the provision of the code violated and the date and time of violation.

#### SECTION 55 - COMMUNITY SERVICE.

A. If the violator wanted community service instead of a fine during the first offense, he shall render it to the Barangay where the violation is committed.

- B. If the violators failed to render the community service without justifiable reasons, he shall double the time or day the community service he must render as provided for in the penal provision.
- C. And if he willfully neglect the community service instructed to by the barangay authorities, he shall be imprisoned of not less than five (5) days and not more than fifteen (15) days.

#### **CHAPTER XIV**

#### **PROVISIONS**

# **SECTION 56 - PENAL PROVISIONS:**

- A. Unless otherwise provided in any chapter or section in this code, any person who shall violate, refuse, omit or neglect to comply with any of the rules and regulation promulgated under this code shall be guilty of misdemeanor and shall be punished by imprisonment of not exceeding sixty (60) days and a fine of One Thousand (P 1,000.00) Pesos.
- B. Any person who shall interfere with or hinder, or oppose any officer, agent of the municipal government authority in the performance of his duty as such under this code, or destroy, displaced, turn upside down the garbage can provided by the municipal government, or shall tear down, mutilate, deface or alter any placard, or notice, affixed to the premises in the enforcement of this code, shall be guilty of misdemeanor and shall be punished by imprisonment of not exceeding sixty (60) days and a fine of One Thousand (P 1,000.00) Pesos.

SECTION 57 - SEPARABILITY CLAUSE - In the event that any section, paragraph, sentence, clause or word of this code is declared invalid by court shall not affect or invalidate the other provisions or portion of this code.

SECTION 58 - REPEALING CLAUSE. Any ordinances, order or regulation inconsistent herewith are hereby amended or repealed accordingly;

SECTION 59 - EFFECTIVITY. This code shall take effect upon its approval.
