



**GENERAL ORDINANCE NO. 18-60**  
**Series of 2017**

**AN ORDINANCE AMENDING ARTICLE III, SECTION 7 OF GENERAL ORDINANCE NO. 33, SERIES OF 2009 OTHERWISE KNOWN AS "AN ORDINANCE IMPLEMENTING THE COMPREHENSIVE ECOLOGICAL SOLID WASTE MANAGEMENT PROGRAM OF TUNGAWAN, ZAMBOANGA SIBUGAY AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF".**

**Be it Enacted by the 18<sup>TH</sup> Legislative Council of Tungawan, Zamboanga Sibugay in its 31<sup>ST</sup> Regular Session Assembled that:**

Section 1. **Title-** This ordinance shall be referred as "An Ordinance Amending Article III, Section 7 of General Ordinance No. 33, series of 2009, otherwise known as 'An Ordinance Implementing the Comprehensive Ecological Solid Waste Management Program of Tungawan, Zamboanga Sibugay and Providing Penalties for Violations Thereof'".

Section 2. **Amendment-** Section 7, Article III of General Ordinance No. 33 s. 2009 is hereby amended by adding par. e, to read as follows:

Section 7. Classification of Waste – Waste shall be properly segregated into five types:  
x x x . . .

e) Types of waste in accordance with DOH guidelines on handling waste in health facilities

Container/Bag Color	Type of Waste
i. Black	Non-infectious dry waste
ii. Green	Non-infectious wet waste (Kitchen, dietary, etc.)
iii. Yellow	Infectious and Pathological waste
iv. Yellow with Black hand	Chemical waste including those with heavy metals
v. Orange	Radioactive waste
vi. Red	Sharps and pressurized containers


Section 3. **Repealing Clause-** All ordinances, resolutions, executive orders and other issuances inconsistent with this ordinance are deemed repealed and modified accordingly.

Section 4. **Separability Clause** – If any part or parts of this ordinance is declared invalid by a competent authority, the other part or parts not affected shall remain operative and subsisting.

Section 5. **Effectivity Clause-** This ordinance shall take effect 15 days after a copy hereof is posted in at least two (2) conspicuous places in the Municipal Hall Building, and published three (3) times consecutively in a local newspaper of general circulation in the locality.
