**GENERAL ORDINANCE NO. 18-62**

**AN ORDINANCE MANDATING THE 25 BARANGAYS OF THE MUNICIPALITY OF TUNGAWAN TO ADOPT THEIR RESPECTIVE BARANGAY IDENTIFICATION (ID) SYSTEM**

WHEREAS, Article II, Section 5 of the 1987 New Philippine Constitution provides that the maintenance of peace and order, the protection of life, liberty and property and promotion of the general welfare are essential for the enjoyment by all the people of the blessing of democracy; the government has the authority to establish a comprehensive solution to serve and protect the people.

WHEREAS, there are about 42,036 barangays comprising the 18 regions from 81 provinces in the Philippines, each barangay should promote the welfare of its people, public and order and good relations among its local residents thus: it is mandated by the government to require an ID to every Filipino citizen to provide public information and interest;

WEREAS, this ID system or card is valid, useful and serves as community clearance in other government and private transactions particularly in military or police checkpoints and law enforcement forces in times of sedition, martial law and other forms of lawlessness;

Be it Ordained by the 18<sup>th</sup> Legislative Council of Tungawan, Zamboanga Sibugay in its 29<sup>th</sup> Regular Session Assembled, that:

**Section 1 . Title** – This Ordinance shall be known as “An Ordinance Mandating the 25 Barangays of Tungawan, Zamboanga Sibugay to Adopt their Respective Barangay Identification (ID) System”

**Section 2 Purpose** - The main purpose of this ID System is to provide information as to whether a certain person possessed a good personal background, law-abiding citizen, no criminal liability, regardless to any ethnic or religion and using the ID card will give value to every Filipino, privilege, a high integrity and loyalty to the government.

**Section 3. Mandate** – In pursuance with Article II, Section 5 of the 1987 New Philippine Constitution, the 25 barangays of the municipality is mandated to adopt their respective Identification (ID) System.

**Section 4. Form and Substance** - The form and substance of the ID card shall depend on the discretion of the barangay concern, subject however to the generally accepted norms and standards. Provided that the following information shall be contained in the ID card: 1. Name; 2. Permanent Address; 3. Date of Birth; 4. Place of Birth; 5. Age; 6. Sex; 7. Status; 8. ID No.; 9. Picture; 10. Height; 11. Weight; 12. Signature of the Punong Barangay.

Section 6. **Effectivity** – This ordinance shall take effect upon its approval.
