**GENERAL ORDINANCE NO. 19-069-19**

**AN ORDINANCE PROVIDING A CASH ASSISTANCE FOR DEATH EXPENSES FOR SENIOR CITIZENS OF THE MUNICIPALITY OF TUNGAWAN, ZAMBOANGA SIBUGAY BY INCREASING THE CASH ASSISTANCE FROM TWO THOUSAND ( Php 2,000.00) PESOS TO THREE THOUSAND (Php 3,000,00) PESOS AND PROVIDING FUNDS THEREOF**

BE IT ORDAINED BY THE 19<sup>TH</sup> LEGISLATIVE COUNCIL OF TUNGAWAN, ZAMBOANGA SIBUGAY IN ITS 5<sup>TH</sup> REGULAT SESSION ASSEMBLED, THAT:

Section 1. **Title** – This Ordinance shall be known as “An Ordinance Providing a Cash Assistance for Death Expenses to Senior Citizens within the Twenty Five (25) Barangays of Tungawan, Zamboanga Sibugay and providing funds thereof;

Section 2. **Scope and Coverage** – The Cash Assistance for death expenses under this Ordinance shall apply to all Senior Citizens who are residents of Tungawan, Zamboanga Sibugay regardless of their race, social and economic status;

Section 3. **Beneficiaries** – In case of death of the Senior Citizens, the beneficiaries shall entitled to receive payment of the said Cash Assistance, subject to the submission of the requirements herein. The following shall be the order of right to claim for the beneficiaries of the deceased;

Section 4. **Documentary Requirements** – To avail this cash assistance the following documents must be submitted:

- Original or Authenticated photocopy of the Death Certificate;
- An identification card issued by the Office of the Senior Citizens Affair (OSCA) of the place where the Senior Citizens reside;
- Valid ID of the Beneficiary

Section 5. **Funding** – For the proper implementation of this ordinance, the Local Government Unit of Tungawan, Zamboanga Sibugay shall allocate in its yearly Annual Budget in the General Fund the necessary funds intended for cash assistance for death expenses for Senior Citizens of the Municipality of Tungawan effective January 1, 2020 and every year thereafter;

Section 6. **Administrative Provisions:**

- All claimants of Cash Assistance under this Ordinance shall commence with the filing of the documentary requirements stipulated under Section 4. hereof at the office of the Municipal Mayor or Office of the MSWDO;
- All claimants of Cash Assistance under this Ordinance shall be processed and settled within Five (5) working days from the date of filing;
- No claims for Cash Assistance under this Ordinance shall be process if said claim was made more than One (1) year after death happened;


Section 7. **Repealing Clause** – All ordinances which are inconsistent or in conflict with the provisions of this ordinance are hereby repealed or modified accordingly.

Section 8. **Separability Clause** – If for any reason, any Section or provision of this ordinance is declared unconstitutional or invalid, other section or provisions which are not affected by such declaration shall continue to be in full force and effect.


Section 9. **Effectively** – This ordinance shall take effect on January 1, 2020.
