RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE CARLNAN CANONES CLIMACO TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE ENVIRONMENTAL MANAGEMENT BUREAU -DEPARTMENT OF ENVIRONMENTAL AND NATURAL RESOURCES (EMB-DENR), REGIONAL OFFICE IX, REPRESENTED BY ITS REGIONAL DIRECTOR JOSEFINO P. BELOCURA, JR., FOR THE IMPLEMENTATION OF THE OBJECTIVES OF RA 9003 PARTICULARLY IN THE UPGRADING FOR THE OPERATION OF MATERIALS RECOVERY FACILITY, PROPER SEGREGATION AT SOURCE AND SEGREGATED COLLECTION IN EVERY BARANGAY OR CLUSTER BARANGAYS OF TUNGAWAN, ZAMBOANGA SIBUGAY

WHEREAS, the EMB-DENR is mandated to monitor and implement the programs for the environmental protection and management, specifically the solid waste management:

WHEREAS, as provided by R.A. 9003, LGUs are given direct responsibility in the strict implementation of solid waste management, particularly the safe waste collection, disposal and recovery by establishing the Material Recovery Facility (MRF);

WHEREAS, there is a need to enter into a MOA to fortify the partnership of the Local Government Unit of Tungawan and EMB-DENR in developing and maintaining solid waste management program with the municipality as required by law and to be able to release fund support for the LGU;

WHEREFORE, THE 19TH LEGISLATIVE COUNCIL OF TUNGAWAN, ZAMBOANGA SIBUGAY IN SESSION HEREBY

RESOLVED, to authorize, as it is hereby AUTHORIZED, the Local Chief Executive Carlnan Canones Climaco to enter and sign a Memorandum of Agreement (MOA) with the Environmental Management Bureau- Department of Environmental and Natural Resources (EMB-DENR), with office address at Lantawan, Barangay Pasonanca, Zamboanga City, represented by its Regional Director Josefino P. Belocura, Jr., for the implementation of the objectives of R.A. 2003 particularly in the upgrading for the operation of MRF and proper segregation at source and segregated collection in every barangay or cluster barangays in the Municipality of Tungawan, Zamboanga Sibugay.
