RESOLUTION AUTHORIZING THE LOCAL CHIEF EXECUTIVE CARLNAN CANONES CLIMACO TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY REPRESENTED BY ITS REGIONAL DIRECTOR MARIA THERESA M. CAMBA, FOR THE IMPLEMENTATION OF THE PROJECT: "FREE USE OF THE TECH4ED PLATFORM WITH CONDITIONAL TRANSFER OF TECH4ED CENTER EQUIPMENT PACKAGE" IN THE MUNICIPALITY OF TUNGAWAN, ZAMBOANGA SIBUGAY
